8. UNFINISHED BUSINESS

A. Big Stone 2 Update

Hal Becker said there had been much discussion and several newspaper articles concerning the set back of the Big Stone 2 project. Two administrative law judges voted against the construction of the new transmission lines. The CMMPA is disputing the findings of the judges and has filed a letter of appeal to the Minnesota Public Utilities Commission which can approve the project and over ride the administrative law judge's report. Delano Municipal Utilities will post articles and our response on the utilities web site. The Governor of South Dakota has spoken in favor of construction of the coal powered plant and the need for the new transmission lines.

B. Approve the CMMPA-NSP Amendment No. 1

Hal Becker said the agency and the Delano Municipal Utilities had been working well over one year to reach an agreement with XCEL Energy on the method used to calculate billing to the utilities. The amendment to the October 11, 1994 Letter Agreement (NSP-55 Contract) will lower wholesale costs by ½ cent per kilowatt hour and includes a cash settlement of \$400,000.00 to the agency with approximately \$100,000.00 of that amount to be distributed to Delano Municipal Utilities.

Motion by Tim Falde and seconded by Randy Keranen to approve Amendment No. 1 to the Central Minnesota Municipal Power Agency and Northern States Power Company (NSP) Agreement of October 11, 1994 also known as the NSP-55 Contract.

9. NEW BUSINESS

Randy Keranen asked for a brief update on the highway 12 project. Hal Becker said the project is going well and Park Construction was doing a good job with the installation of the water mains and the Minnesota Department of Transportation as well as Park Construction was happy with the progress.
