A. Review the Financials for January 2021

Chris Hart provided a financial review of the cash flow and financial dashboard for the month. In the Electric Department, revenue is 1.11% under budget for the month. We used \$25,963.49 cash more than planned for the month. Year to date is \$25,963.49 cash ahead of budget. Electric expenses are 3.78% over budget for the month while year to date expenses are 3.78% over budget.

In the Water Department, revenue is 68.57% over budget for the month. We are \$64,167.82 cash ahead of plan for the month. Year to date we have we are \$64,167.82 ahead of budget and expenses are 4.52% under budget.

# 7. GM Report

A. CIP (Conservation Improvement Update) Brittany Moorhouse presented that CIP is already at 55.7% of our 2021 goal. With the projects in progress, we will easily make our 2021 goal.

B. General Manager Update was presented by Paul Twite. Mr. Twite talked about Texas and the record temperatures. Paul also mentioned the cost of energy during this time and how important our engines are in a time of emergency.

Paul also talked about the replacement for Sub A Transformer. We received bids from six different vendors. The lead time for a new transformer would be ten months. DMU is reviewing all options to pay for the new transformer.
