Chris Hart provided a financial review of the cash flow and financial dashboard for the month. In the Electric Department, revenue is 16.52% over budget for the month. We used \$37,487.60 cash more than planned for the month. Year to date is \$63,481.22 cash ahead of budget. Electric expenses are 23.71% over budget for the month while year to date expenses are 13.84% over budget.

In the Water Department, revenue is 25.38% over budget for the month. We are \$23,526.43 cash ahead of plan for the month. Year to date we have we are \$87,694.25 ahead of budget and expenses are 2.58% under budget.

7. GM Report

- A. CIP (Conservation Improvement Update) Wendy Neu presented that CIP is already at 88.4% of our goal for the year. Mrs. Neu will start including the line loss figure to the CIP spreadsheet. KLN's numbers have started coming in and the discussion has been to pay them in one to two years.
- B. General Manager Update was presented by Paul Twite. Mr. Twite talked about CMPAS disbursements approved for 2021. The disbursements amount would be equaling around \$150,000. Mr. Twite also talked about Montrose water having high Manganese level. Here at Delano, we test for Manganese daily, and our levels are at 0.05PPM. This is 99.95% removal from the groundwater. Mr. Twite talked about allotting a certain amount of our cash reserve into CDs or T-Notes, Staff will provide suggestions in April. Wendy and legal counsel have been working on personnel policies and will have updates to come in the next couple of months. DGR Engineering will be attending the April Commission meeting, with the topic of capital plan and costs of construction for a new Transformer.

Betsy Moran provided an update about the new housing developments around Delano. Ms. Moran also talked about hiring Engineer Shawn Louwagie full time for the City.
